

The Seaford Twinning Association asked me to be their President and I was honoured to visit one of their recent events held in Barcombe.

There have been other events too numerous to mention.

Unfortunately I also attended the commemorative church service for Mr Don Mabey MBE which attracted over 300 mourners. Mr Mabey was an incredible person who did so much for so many organisations in Seaford so I am very proud to announce that Seaford Town Council have supported my call for a special award to be created in Mr Mabey's name. The annual award of a shield and certificate is to be presented to a Seaford resident who has made a considerable contribution to the town. I was able to recently promote this award at a special commemorative programme on Seahaven Radio.

My two charities for my term in office are the Seahaven Storehouse, known locally as the Seaford food bank, which distributes food parcels to impoverished Seaford residents from its base in the Community Church in Vale Road and Waves which was set up in 1999 by the Seaford Baptist Church and helps Seaford families in times of need from its family centre at 8 Church Street, the two charities complement each other perfectly.

One of my main aims during my term of office is to bring the 185 known voluntary organisations in Seaford together in like-minded groups so that they can work together and improve their co-operation and contribution to our town. This is in progress at this time.

My sincere thanks goes to the Town Clerk, officers and staff of our council for their invaluable help and support and also to my fellow councillors for allowing me to represent Seaford Town.



MESSAGE FROM THE LEADER OF SEAFORD TOWN COUNCIL

Every year gets harder with increasing funding cuts passed on to us by the Government.

Councillor Barry Burfield has worked extremely hard on our budget and has made great improvement to the way our finances are dealt with.

In line with the Seaford vision and Impact Seaford, it was highlighted that there is the need for investment in business tourism, youth and leisure facilities for Seaford.

The Salts master plan will go a long way to achieving this with various funding available to develop the Salts area into a major recreational facility for all to use.

Our councillors are still campaigning for improvement to the local health services, with the result of Horder Health Care coming to our town.

INTRODUCTION

Welcome to the 2013/14 Annual Report, this is the full report of the Town Council.

A summary will be published in the next Town Council newsletter.

This report has been produced and made available prior to the Seaford Town Forum to be held on 29 April 2014 at 6pm at Seaford Baptist Church, Belgrave Road, Seaford. The Town Forum is a meeting of the electors of the Town of Seaford and provides an opportunity for residents to discuss the information provided and to question the Council on its activities during the year. Any resident of the town is welcome to attend this meeting.

Seaford Town Council serves the Town of Seaford with a population of around 24,000 residents and has been awarded the Quality Council Status for meeting a set of quality criteria.

We deliver many services in the town, such as the provision of some of the parks, playing fields and recreation areas including the Crouch Gardens, the Salts Recreation Ground, the Martello Fields and Tower, the Seaford Head Golf Course, Arts@theCrypt at 23 Church Street, the Seaford Head Nature Reserve and the allotments in Sutton Drove.

Our aim is to give residents information about the Town Council and the services which we deliver in the town, to outline how we are dealing with current challenges and highlight our plans to meet community needs and deliver quality services in the next year and beyond.

Seaford Town Council is one of around 9,500 Town and Parish Council's within England. Town and Parish Councils are the first tier of local government and work closely with the other tiers of local government to try and achieve the best for their local communities. During the year, we have worked closely with Lewes District Council and East Sussex County Council on a number of issues and a number of Town Councillors are also District Councillors. We run a comprehensive Councillor training programme in conjunction with the Sussex and Surrey Association of Local Council's Executive Officer.

Elections to the Town Council are normally held every four years, the last in May 2011 and the next are due to be held in May 2015.

Agendas and minutes for all Town Council meetings are published on our website and are available for inspection at the Tourist Information Centre, 37 Church Street, or at Seaford Library. All meetings of the Town Council are open to members of the public and the Council welcome views and comments relevant to the Committee during the Public Participation section of the Committee meeting.



THE SALTS RECREATION GROUND

The Salts Consultation took place over two days in August, the event was well attended receiving hundreds of positive responses seeking improvement to The Salts children's play area, as well as the skate park, tennis and the recreation ground as a whole.

Displays were set up on the 7th and 10th August and all of the school children and families were invited to come along and give their views.

Some funding has been secured with more needed; but following a full review of the consultation results, research into previous projects at The Salts and projects in other parks, a development plan has been produced that will allow the Town Council to apply for funding and seek support from potential project partners.

Improvement works to The Salts changing rooms continued with new showers and tiling, further internal redecoration; and with the hard work of members of Seaford Cricket Club, decoration of the outside of the building.



THE MARTELLO FIELDS

Following a smaller event taking place in 2012, The Seahaven Veterans and Armed Forces Day returned to its full glory at Martello in 2013 with military vehicles on display, the Mini Tanks back for the second year running, lots of Community Stalls, entertainment and the Funfair.

Most importantly the weather stayed clear making it one of the best years yet, even bringing in Dog displays and Owls.

Other events returning for another year included the Triath-Ion, Donkey Derby, Funfair and Seaford Bonfire night.



SEAFRONT

New Mixed Waste bins were installed on the seafront just in time for the summer holidays, the project was introduced in order to reduce costs and simplify the waste collections, improve fire resistant and to de-clutter the promenade.

A new public information board is now in place at the West View Kiosk thanks to Frankie's

Beach Café and leaflets will also be on display at the Kiosk improving public information.

Following the winter storms, the Seafront and Seaford Head now need care and attention; safety is being taken into consideration in more detail on Seaford Head Estate and the seafront is gradually being restored.

This modern development offers a flexible facility for golfers, members of the public and organisations looking for simple refreshment or holding of larger events.


This clubhouse will give Seaford an exceptional venue taking advantage of the beautiful views across Seaford Bay.

THE BASE

Seaford Town Council has recently taken over management of the Base, and is now dealing with all bookings and enquiries.

The Base is situated within the Salts in Seaford, and is available for hire by local residents, and groups.

It is mostly used by local bands that need a space for rehearsals.

The Base is well equipped with everything needed for a rehearsal space; a drum kit, amplifiers, keyboard, freestanding microphones and stereo.

The Base is available for one-off hires or can be booked on a regular basis through Seaford Town Council.



ARMED FORCES DAY

Hundreds of visitors, including many veterans and their families, crowded onto the Martello Fields in Seaford for the Seahaven Veterans and Armed Forces Day on Saturday 29th June 2013.

The event was organised by Seaford Town Council and the Seahaven Branch of The Royal Society of St George, for the whole of the Lewes District.

Throughout the day there were many arena displays, including the Seaford Rock and Jazz Band, a Flyball Dog display, Seaford Lifeguards, the Up the Tempo Dance Group and a display of drill by the Newhaven detachments of Air Training Corps and the Army Cadet Force.

The Parade started at 12.30, marching behind the piper and the Seaford Sword from the Martello Tower down to the Arena.

There were many charities and other stalls around the field as well as a Fun Fair, and a special

mini-tank arena where youngsters could have the thrill of driving a realistic looking mini tank.

Helping the day go with a swing was the Tavern in a Tent, provided by the Seaford and Seaford Martello Rotary Clubs. The Royal Society of St George, as a special tribute, gave all veterans on parade a voucher for their first drink in the Tavern.

Finance for the day was not only provided by the organisers, but it was supported by the town councils of Newhaven, Peacehaven and Telscombe. Over £340 was raised towards the cost of the event by the sale of soft toys and a bucket collection. The profits of the day was donated to Blind Veterans UK (St Dunstans) and their President Ray Hazzan.





SEAFORD CHRISTMAS MAGIC

On the night of 6th December Late Night Shopping took place and it was yet another success for the town of Seaford. It was filled with many stalls and fairground rides offering the magical delights we all like over the festive period. Many people came to see the annual switching on of the lights which were
